

GET THE MOST FROM TREATMENT WITH NUEDEXTA

You and your doctor have made the important decision to treat your PBA with NUEDEXTA, the first and only treatment approved by the FDA to treat PBA.

PBA (PseudoBulbar Affect) causes sudden, frequent, uncontrollable episodes of crying and/or laughing that are exaggerated or don't match how you feel. PBA occurs in people living with certain neurologic conditions or brain injury. These unpredictable episodes can leave you feeling misunderstood and frustrated. Treatment with NUEDEXTA can make a difference by reducing PBA episodes.



As you continue your treatment it's important to follow your dosing routine, give your treatment time to work, keep track of your results, and use the Co-Pay Savings Card. Keep this Treatment Guide and refer to it as often as you'd like.

WHAT IS NUEDEXTA® APPROVED FOR?

- NUEDEXTA is approved for the treatment of PseudoBulbar Affect (PBA). PBA is a medical condition that causes involuntary, sudden, and frequent episodes of crying and/or laughing in people living with certain neurologic conditions or brain injury. PBA episodes are typically exaggerated or don't match how the person feels. PBA is distinct and different from other types of emotional changes caused by neurologic disease or injury.
- NUEDEXTA is only available by prescription.

ARE YOU FOLLOWING YOUR DOSING ROUTINE?

When you take the prescribed dose at the same time each day, you are keeping the right amount of medicine in your system. This allows the medicine to work properly to help you reach your goal of fewer PBA episodes.



This dose introduces NUEDEXTA to your body.

Important Dosing Guidelines

- · You can take NUEDEXTA with or without food.
- NUEDEXTA at your usual time.
- 12 hours in between your doses.

IMPORTANT SAFETY INFORMATION Before you take NUEDEXTA, tell your doctor:

· If you are taking monoamine oxidase inhibitors (MAOIs), quinidine, or quinidine-related drugs. These can interact with NUEDEXTA causing serious side effects. MAOIs cannot be taken within 14 days before or after taking NUEDEXTA.



ARE YOU GIVING YOUR **TREATMENT TIME TO WORK?**

NUEDEXTA is meant to work over time. You should expect to see your best results by about 90 days.*

In a clinical trial, patients who took NUEDEXTA saw a significant reduction in PBA episodes. In a 12-week trial, patients experienced:



Your results may vary.

Compared to baseline, patients taking placebo experienced 45% fewer episodes at Week 12, and 29% were completely free of PBA episodes in the final 2 weeks of the 12-week study.*

What might happen if you stop treatment

To continue the benefits of NUEDEXTA, take daily as directed by your physician. In a clinical trial, at the beginning of the second week of treatment, patients increased their NUEDEXTA dosage to 2 capsules each day. After the clinical trial was over, many patients were monitored for another 3 months. During the transition between trials, some patients had a gap in treatment. Many of those who stopped saw their PBA symptoms increase after a 48-hour break in treatment.[†] From time to time, your doctor may want to determine if you still need to take NUEDEXTA. For some patients, PBA symptoms may improve on their own.

WHAT ARE THE SIDE EFFECTS **OF NUEDEXTA?**

IMPORTANT SAFETY INFORMATION (CONTINUED) Before you take NUEDEXTA, tell your doctor:

- quinidine-like drugs.
- certain other medicines can interact causing side effects.
- If you have myasthenia gravis.

Some of the most common side effects when taking NUEDEXTA are:

- Vomiting
- Weakness
- Swelling of feet and ankles

· If you have previously had an allergic reaction to dextromethorphan, quinidine or

· About all medicines, herbal supplements, and vitamins you take as NUEDEXTA and

· If you have had heart disease or have a family history of heart rhythm problems. NUEDEXTA may cause serious side effects, including changes in heart rhythm. If you have certain heart problems, NUEDEXTA may not be right for you. Your doctor may test your heart rhythm (heartbeats) before you start NUEDEXTA.

ARE YOU SEEING RESULTS?

Keeping note of the differences you see during treatment with NUEDEXTA will help you remember what's changed, help your doctor understand how NUEDEXTA is working for you, and allow you to reflect on what a change in episode frequency has meant for you.

What differences have you seen in your daily life due to a change in PBA episodes? Even a small change is important to remember.

Let your doctor know about your progress by sharing these notes.

IMPORTANT SAFETY INFORMATION (CONTINUED)

While taking NUEDEXTA, call your doctor right away:

- · If you feel faint or lose consciousness.
- · If you experience lightheadedness, chills, fever, nausea, or vomiting as these may be signs of an allergic reaction to NUEDEXTA. Hepatitis has been seen in patients taking quinidine, an ingredient in NUEDEXTA.



ARE YOU USING YOUR CO-PAY SAVINGS CARD?

Use your Co-Pay Savings Card for every refill. If you have private insurance, you may pay as little as \$0* for a 90-day prescription of NUEDEXTA. Check with your doctor and insurance provider to see if a 90-day or 30-day prescription is the best value for you.

IMPORTANT SAFETY INFORMATION (CONTINUED) While taking NUEDEXTA, call your doctor right away:

- If you have unexplained bleeding or bruising. Quinidine, an ingredient in NUEDEXTA, can cause a reduction in the number of platelets in your blood which can be severe and, if left untreated, can be fatal.
- If you feel dizzy, since it may increase your risk of falling.
- If you have muscle twitching, confusion, high blood pressure, fever, restlessness, sweating, or shivering, as these may be signs of a potential drug interaction called serotonin syndrome.


